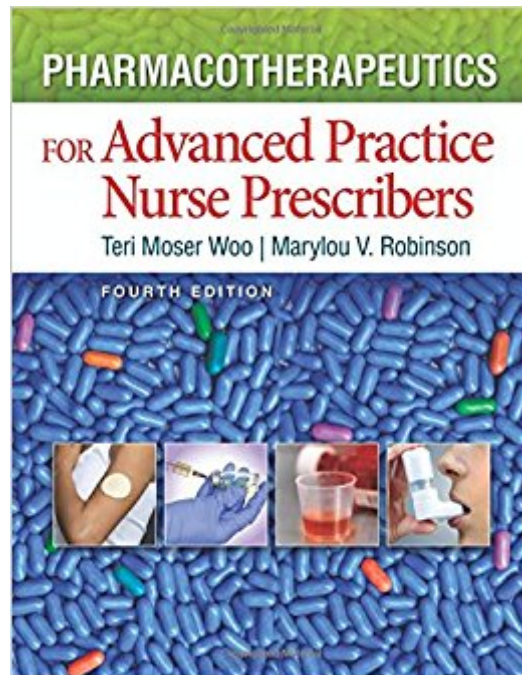

Online resources are terribly lacking. Power points and practice questions are locked away under an instructor code. The text itself has very few illustrations with mid-1990's graphics. Quality text books use illustrations to enhance and promote learning. Bullet points and margin notations for emphasis. An endless list of techniques to promote assimilation of material. The reader is clunky and miserable. I will avoid all future Davis purchases. Glad I rented this instead of buying it, however it is unlikely to be even worth the rental price.

The online resources are a waste of time, a few case studies and 5 videos that will not work. The

book is poorly written and organized. The first page of the introduction tells how patients would rather go to nurse practitioners than physician assistants because NPs spend more time teaching. I work with 3 wonderful PAs, who all encouraged me to pursue my NP, why would you write about your peers in such a way. I continually have to research my own material to ensure I have the most current information as I have found many of their resources over 20 years old, one was over 30 years old. I had to waste my money on this book because it was a requirement for my class.

The information on this book for me is everywhere. Yes, there are bunch of helpful information.. The access code doesn't provide much at all. I am very frustrated with the access code. I purchased the book new so I could use the access code and additional resources. Oh what did I know? I should have spent way less money on the used book instead. I also called the company and asked them to fix my e-book problem and not only they didn't help but transferred me to different lines and asked a whole bunch of my personal information.

The book could be better organized. I am disappointed and do not feel that it is worth the money. If it were not a required text book I would not have wasted my money on it.

Good book but I find it repetitive and I don't like that it doesn't give a prototype drug or show both brand and generic name in the tables.

This is required for my course. There are some errors, such as misspellings within the text; however, it still gets the job done - it's nothing you cannot understand. Great breakdown and flow with reading. I still like the book. I did rent this text because of the negative comments, but I may purchase it eventually- debating.

This book does a decent job of explaining advanced pharm in language that is understandable. Drugs are grouped a bit oddly in some of the chapters, and I've noticed some rather glaring errors for a textbook (like referring to leukotriene modifiers incorrectly as agonists when it should have been antagonists), but it's still better than 2 other advanced pharm books I've used.

TERRIBLE! Confusing. It's informative at first, then the sections just mentions many other drugs and things to note randomly all throughout, not organized well at all
