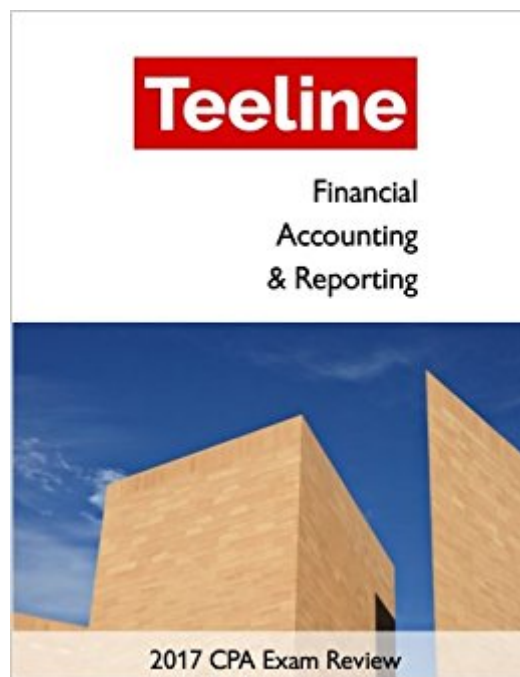

The first time I attempted the CPA, I passed BEC then failed FAR. I actually walked out of the FAR exam, I didn't try to answer any of the modules because I felt I'd done so poorly up to that point. After a three-year break, I tried again and this time I used the new Teeline, along with my old copy of Wiley as a backup. I scored an 89! I still have a long way to go, but I just bought Teeline AUD, only 30 pages, and I already passed BEC one time so I know I can pass again.

Great book! Using T-accounts for problem-solving gives you the best chance to pass the exam. Allows you to answer questions by rote, without critical thinking, and saves time. Teeline has all applications: cash-to-accrual, cash flow statement, inter-segment transactions and foreign currency transactions. Highly recommended.
