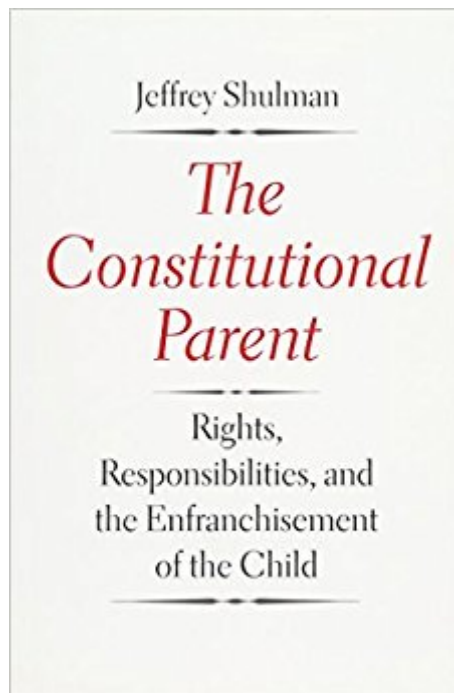

Despite this long held tradition, it is a common presumption that parents have a fundamental right to raise their child as they wish without state interference. In this wonderful book, Shulman argues against the notion that parents have a sacred right to control their child's upbringing. Parents, he emphasizes, are entrusted with their child's upbringing. It is best to think in terms of duties, rather than rights. This notion, contrary to the beliefs of the parents' rights movement is the predominant tradition in American law.
